### WITHDRAWAL, REDEMPTION AND DEMONETISATION OF ONE CENT COINS

NOTICE is hereby given that—

1. with effect from the 1st day of April, 2018, the Central Bank shall call in the one cent coin denomination of the currency of Trinidad and Tobago for the purpose of withdrawing the coin from circulation;
2. with effect from the 3rd day of July, 2018, the one cent coin shall cease to be legal tender for cash payment within Trinidad and Tobago;
3. the Central Bank (Withdrawal, Redemption and Demonetisation of One Cent Coins) Regulations, 2018 (Legal Notice No. 35 of 2018) have effect for the purposes of—
  - (a) the withdrawal and redemption of the one cent coin; and
  - (b) the mandatory rounding off of payments to the nearest multiple of five cents for transactions effected in cash.
